NOTIFICATION OF PESTICIDES *Healthy Schools Act of 2000*

§48980.3–Notification of Pesticides Pursuant to the requirements of Assembly Bill 2260, the Healthy Schools Act of 2000, we are providing this information regarding the Sutter County Superintendent of Schools' pest control plan for school year 2017-2018.

The County Office has established an annual pest control services contract with a qualified, licensed pest control applicator company. This service will consist of regular inspections for typical household pests at County Office Building and our school campuses. If, during the course of the inspection, indications of activity are discovered, treatments may be applied to control insects. Working with the applicator to develop strategies to reduce the need for treatments, we are committed to keeping such applications to a minimum, using only products appropriate for use on school campuses in all cases. The County Office supports the use of non-toxic products and uses non-toxic products in most cases.

County Office maintenance staff will inspect the exterior of all school buildings on a quarterly basis and inspect the food service areas (kitchens and storerooms) on a monthly basis. These inspections are for ants, silverfish, flies, and other typical household pests. If non-toxic products are not effective and actual pesticide treatment is required, the products that may be used and are approved for use on our sites are listed below (this includes treatment for weed abatement, as applicable):

Anderson's Turf Fertilizer with Herbicide; Potash 15mg/m³, Urea 15mg/m³, Limestone 15mg/m³, Clay 15mg/m³, Dithiopyr

Turf Gold 15-2-24; Urea, Sulfur, Mono-ammonium Phosphate, Ammonium Sulfate, Diammonium Phosphate, Potassium Chloride, Sulfate of Potash, Iron Oxysulfate

Glyphosate Pro 4; Glyphosate in the form of it's isopropylamine salt

Turf Royale 21-7-14; Ammonium Nitrate, Potassium Sulfate, Calcium Phosphate, Diammonium Phosphate, Monoammonium Phosphate.

Maki Mini Blocks, Maki Paraffin Blocks; Bromadiolone

PT 221L; Lambda-Cyhalothrin, 2-Propanol, Petroleum Distillates

P.I.; Pyrethrins & piperonyl butoxide

Prelude Termiticide; Permethrin

DY-KICK CS; Cyfluthrin

In the event of treatment, the site will be posted with a written sign at least 72 hours prior to the application. If you require further information, or if you would like to receive prior notification within 72 hours of individual applications at a specific location for this school year only (request must be updated each year), you may submit a request in writing, including your name and address, phone number, worksite, and classroom number (if applicable), to the following address:
