## **Expanded Learning Opportunities Grant Plan**

The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

#### **Plan Descriptions**

A description of how parents, teachers, and school staff were involved in the development of the plan.

A survey was sent to parents asking for them to rank possible options for use of funds to determine which options were most important to families.

Teachers were polled in a staff meeting and by emails regarding what they thought was most appropriate and able to be completed for greatest benefit to students.

Students were given a Panorama survey through school counseling to determine areas of need.

A description of how students will be identified and the needs of students will be assessed.

- 1. Students will be identified for credit recovery based on their transcripts. Any student with a failing grade in the previous 2 years of high school will be offered credit recovery options.
- 2. Students offered an extended completion time for current courses will be identified by teacher recommendation after meeting with student and guardian to ensure meaningful participation.
- 3. Students offered extra curricular tutoring sessions in the 2021-22 school year will be identified by teacher recommendation, parent request, and student achievement scores.
- 4. Students identified for extra counseling support will complete the referral to counselor process and may be referred by any school staff member, self-referred, or by their family unit.
- 5. Students who are taking Spanish as a foreign language will be assigned a supervising tutor/para-educator to work with them in completion of their foreign language requirements.
- 6. Students who have been identified as English Learners and need assistance with academic support will be given push in and occasional supplemental pull out support with a bilingual para-educator.
- 7. Creation of a local Meal Program to support the nutrition and health needs of students.

Parents and guardians will be informed via Parent Square announcements, announcements placed on Google Classrooms by teachers, flyers and enrollment forms sent home to parents by US mail and email, and/or personal phone calls or conferences between parent/guardian and the school staff.

A description of the LEA's plan to provide supplemental instruction and support.

1. Summer credit recovery will be offered to qualifying and interested high school students to make up credit over the summer for any failed course. These courses will be offered in an online independent study format through which students will take at their own pace. Work will be completed on campus Tuesday through Friday from 9 am to 12 pm under the supervision of a credentialed teacher.

- 2. Students who qualify and choose to participate will be offered an extension of course access to assignments for a period of two (2) weeks beyond the scheduled school year to complete any missing assignments to make up points to pass their currently enrolled courses.
- 3. Extra curricular tutoring, supervised credit recovery lab time, and other learning activities will be offered before and/or after regular school hours to engage students, create a positive learning environment, and accelerate learning.
- 4. A counselor will be increased by one day per week to assist with student re-engagement and Social Emotional Learning Strategies and supports.
- 5 and 6. A para-educator will be hired who speaks English and Spanish to assist and tutor students in the Spanish courses and students who are EL learners for a combined one FTE.
- 7. Hire a nutrition program coordinator/chef and purchase the software and kitchen equipment to prepare and serve meals to all students.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

ELO funds will be coordinated with reimbursement funds for the beginning meal program to ensure that appropriate appliances and tools are purchased and the kitchen is rented and staffed for healthy, locally sourced meals to be stored, prepared, and served to all students. Special education funds will continue to be used to support the hiring of part time paraprofessionals to serve students with special needs in the classrooms, alongside the new paraprofessional who will be hired using the ELO funds to assist with students learning Spanish and families speaking Spanish. Teachers will be paid to extend the school year by two weeks to allow for credit recovery for students in high school classes needing a little more time to finish assignments this semester. Additionally, teachers and paraprofessionals will be hired to staff after school periods designed for credit recovery at the student's individual pace using the programs the school has purchased with supportive funds. An additional day of a school counselor was made possible using ELO funds in coordination with other funds to support student reengagement, social emotional learning, and student and staff mental health needs.

### **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). ### **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

#### For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
