Barbara Henderson reviewed the Collective Bargaining Agreement for Sutter County Superintendent of Schools Employees Association (CSEA) with the Board. Page 3 that was contained in the Board Packet was replaced with an amended page 3. There was a 5% increase to the salary schedule for CSEA as well.

   \$19.32 was received from SaveMart per Gail; the One Stop Adult Education Class uses a card that reimburses the user with bonus dollars.
- 10.0 BUSINESS SERVICES REPORT
  - 10.1 <u>MONTHLY FINANCIAL REPORT JUNE 2016</u> Barbara Henderson reviewed the Summary Report of Revenues, Expenditures and Changes in Fund Balances for the month of June 2016 with Board Members.
  - 10.2 <u>INVESTMENT STATEMENT REPORT JUNE 2016</u> Per Gail Atwood – SCSOS is still making more interest than any other surrounding counties. The average yield is 1.49%

#### 11.0 POSITION RECLASSIFICATION – INCREASE OVER \$10,000

- Gail Atwood noted that Education Code 1302 states if any salary increase is more than \$10,000 it must be brought to the attention of the Board for discussion. SCSOS had a Salary Review Board analyze the salaries of employees at Shady Creek and two employees were severely underpaid. Bill Cornelius, retired Superintendent of SCSOS, said it was important to be competitive in these salaries. The new salaries for the two employees, Chris Little, Lead Naturalist, and Lorenzo Cloutier, Food Services Supervisor, increased approximately \$20,000, keeping in mind that management employees pay 100% for their benefits.
- 12.0 <u>ITEMS FROM THE SUPERINTENDENT/BOARD</u> 12.1 <u>OTHER</u>

Superintendent Dhillon stated that the remodel work at the 300 building has been completed and staff has relocated to the building. The official name of the building is Educational and External Services (EES) Offices.

Superintendent Dhillon reported on the following:

Senate Bill 1050: FRA will be exploring the opportunity to apply for the College Readiness Block Grant. It provides minimum funding of \$75,000 per LEA over a three year period. The funding can be used for providing professional learning opportunities for teachers, counselors and administrators to improve A-G completion rates, developing curriculum that meets A-G requirements and expanding coursework to ensure students are college ready.

A Multi-tiered System of Support is being developed by FRA. The budget provides \$20 million in one-time Prop 98 funds. This opportunity will be explored as further details are developed. It is anticipated that a 20% match will be required.

Senate Bill 527: This Bill would provide \$18 million one-time funding for grants to reduce truancy and support pupils at risk of dropping out of school.

Assembly Bill 2122: Due to the shortage of teachers, this Bill will provide grants to K-12 LEA's to support classified employees to enter teacher preparation programs. The total allocated is \$20 million.

Senate Bill 1756: \$10 million was allocated for higher education to develop four year integrated teacher preparation programs. Teachers would obtain their Bachelors and preliminary teaching credential in four years.

Senate Bill 915: This Bill would strengthen teacher recruitment statewide.

The State Board of Education met to continue their work on accountability (to support CCSS and ESSA requirements) and LCFF Evaluation rubrics. The State Board has a deadline of September to adopt the new school and district improvement and accountability system for 2017-18

June McJunkin affirmed the date of the SCSOS In-Service is August 8th. Jim Richmond would like to accompany Dr. Dhillon to different school districts to meet the superintendents. Bal stated that Lisa Richardson is working on the dates and times for school visits and that she will contact the Board to let them know when they are set.
