The Sutter County Superintendent of Schools (SCSOS) office has adopted the California Uniform Public Construction Cost Accounting Act ("informal bidding act") and invites all interested licensed contractors to submit their firm for inclusion on the Informal Bidding List for each respective calendar year.

The California Uniform Public Construction Cost Accounting Act (CUPCCAA) provides for alternative bidding procedures pursuant to public contract code 22000 through 22045 when an agency performs public project work by contract:

- (a) Public projects of \$60,000 or less may be performed by force account, negotiated contract, or by purchase order (PCC §22032(a)).
- (b) Public projects of \$200,000 **or less** may be let to contract by the informal procedures set forth in the Act (PCC §22032(b)).
- (c) Public projects of **more** than \$200,000 shall be let to contract by formal bidding procedures (PCC §22032(c))

Firms submitting an application must have a valid California contractor's license and be registered with the Department of Industrial Relations (DIR) per California Labor Code section 1725.5. Pursuant to SB 854, no contractor or subcontractor may be listed on a bid or awarded a contract for a public works project unless the firm has current registration with the DIR.

Contractors that would like to be added to our Informal Bidding List must complete the attached form and return it via mail, email, or in-person to the Facilities, Maintenance, Operations, & Fleet Department as identified at the bottom of the application. Our office hours are 8:00 a.m. to 4:00 p.m., Monday through Friday. Contractors must submit a new application each year.
