### **DUTIES AND RESPONSIBILITIES:**

Conducts ongoing data analysis studies and surveys involving the development and/ or maintenance of programs under Educational Services, assists in the development and implementation of program procedures; develops and revises forms, procedures, and written materials for use in assigned programs; monitors grant activities and expenditures for compliance; provides assessment data analysis for SCSOS programs and Sutter County Local Educational Agencies (LEAs), gathers comprehensive data and analyzes program and student outcomes.

Completes complex data processing activities for the purposes of retrieving, analyzing, reporting, and warehousing data to address student learning, professional development, and program/ LEA continuous improvement activities.

Conducts various cost analysis studies; prepares reports and displays for program accountability and student performance; prepares workload, staffing and space requirement reports; participates in work measurement studies and provides training in program procedures.

Assists with development of new programs and identifies program problems and makes recommendations regarding workload, operations and budget.

May be assigned to special committees to assist in program development; researches program legislation; summarize progress on projects, provides reports on specified grants; compiles data and develops a variety of reports, oral and written presentations.

Assists with monitoring compliance with state and federal mandates, analyzes program goals and achievements, and recommends change as necessary. Interface with county and regional assessment/data specialists, to keep abreast of technologies and emerging trends in student data analysis, for the purpose of providing additional information, developing instructions for and training for staff when appropriate.
