

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).



This chart shows the total general purpose revenue Live Oak Unified School District expects to receive in the coming year from all sources.

The total revenue projected for Live Oak Unified School District is \$26,563,704.00, of which \$20,887,535.00 is Local Control Funding Formula (LCFF) funds, \$1,159,764.00 is other state funds, \$233,152.00 is local funds, and \$4,283,253.00 is federal funds. Of the \$4,283,253.00 in federal funds, \$2,424,590.00 are federal CARES Act funds. Of the \$20,887,535.00 in LCFF Funds, \$4,701,372.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$6,609,418.00 is tied to actions/services in the Learning Continuity Plan and \$20,465,584.00 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:



In 2020-2021, Live Oak Unified School District is projecting it will receive \$4,701,372.00 based on the enrollment of foster youth, English learner, and low-income students. Update on Increased or Improved Services for High Needs Students in 2019-2020



This chart compares what Live Oak Unified School District budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Live Oak Unified School District actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-2020, Live Oak Unified School District's LCAP budgeted \$7,031,141.00 for planned actions to increase or improve services for high needs students. Live Oak Unified School District actually spent \$7,033,833.00 for actions to increase or improve services for high needs students in 2019-2020.
